				Whenever possible, mentor to check weather forecast beforehand to check for potentially hazardous conditions. Try to anticipate conditions and take on board any weather warnings / advisories. If caught out in adverse conditions, stop driving and park in a safe place until conditions improve and regularly update the Mentoring Manager with the situation.			
Passenger behaviour	✓			<p>Mentors will not be asked to transport a young person in their personal vehicle unless the Director / Mentoring Manager / Key worker feel it appropriate and safe to do so.</p> <p>Clear boundaries and rules agreed by young person.</p> <p>If mentor does not feel comfortable transporting young people, then they are not required to do this.</p> <p>If there are unresolved issues with behaviour do not continue with journey and call Mentoring Manager for support.</p>	✓		
Travel Sickness	✓			<p>The mentor will be advised in advance if the young person is known to suffer with travel sickness.</p> <p>Take breaks in journey and ensure there is good ventilation.</p> <p>Travel with cleaning materials and plastic gloves and sickness bags.</p>	✓
